- Language Subject to maintain pattern of 60% weightage to Non-textual & Practical Application and 40% Textual Content (Prose & Poetry).
- > For Class XI Economics the long answer will carry 03 marks in place of 05 marks.
- > For CWSN to keep Google Forms Pattern with MCQs or any other convenient pattern.
- ➤ For Practical, Videos of Experiments may be uploaded and shall be used for viva during first term in view of online classes.
